- Bread, cheese, and wine following service
- Provision of necessary staff to attend funeral service
- Burial third party costs* inclusive of grave purchase, interment fee and grave digger fee
- Wooden cross with name plate (wooden cross added when grave is purchased)
- Advice to executors relating to registration and documentation
- All legal documents necessary for the funeral to take place

The Repatriation plan

What's included?

- Administration of the plan
- Attending to all necessary funeral arrangements in country of residence
- The funeral director's professional services
- All legal documents required for repatriation and funeral services
- Removal to the funeral director's premises in Cyprus
- Care of deceased and preparation for repatriation
- Simple coffin conforming to international travel requirements
- Flight to destination country (freight fee allowance of £1000*)
- Death certificate in language of country of residence and translated to English

UK service

- Delivery from UK airport to funeral directors (within 100km)
- UK service (contribution to UK funeral of up to £2000*)
- Advice to executors relating to registration and documentation
- 24-hour English-speaking emergency helpline

What's not included?

- Additional church service, minister and necessary staff in Cyprus

Third party costs

* This plan includes an allowance of up to £1000 toward costs of repatriating the deceased by air. If a UK funeral service is required, this plan also includes a contribution of up to £2000 toward costs. These may include:

- Use of a Chapel of Rest
- Wood veneer coffin
- Hearse on the day of the funeral plus a conductor and bearers
- Cremation or burial costs

If the cost of these is more than £2000 (or the cost of repatriation by air is more than £1000) then there may be additional expenses that will need to be paid by the estate or next-of-kin of the deceased.

Single payment (i.e. in one lump sum in Sterling or Euros) – you can cancel within 30 days or within 7 days of us telling you who your funeral director is (if this is later). You'll get all your money back. If you cancel after this, you'll get your money back but we'll keep a €374 / £325 charge for administration.
